DSCC reserves the right to request evidence of the manufacturer's capability to produce QPL printed wiring boards as stipulated by paragraph A.4.5.5 of MIL-PRF-55110G, Amendment 3. Please complete and submit the next retention report to DSCC-VQE by December 31, 2010 or loss of qualification may result.

These qualifications listing are valid through the expiration dates indicated by the last 6 digits of the current qualification reference numbers (mmddyy), provided that all requirements of the subject specification are met. A stop shipment/stop production status is effective on the expiration date unless approval is granted by DSCC-VQE to complete existing contracts. Manufacturers are required to inform DSCC-VQE within 3 business days if a failure occurs during group B testing, if production of certifiable product is discontinued, or prior to issuance of a GIDEP Alert and/or Problem Advisory on their QPL products.
